Title of the Qualification	BPEC Level 2 Diploma in Smart Metering-Gas
Qualification Number (QN)	600/1889/6
Overview	The BPEC Level 2 Diploma in Smart Metering-Gas requires the completion of knowledge and practical assessments and the assessment of performance in the workplace.
-Who is this qualification for	The qualification is for learners aged 16 years or older who are employed in the Smart Metering industry/have access to work experience.  The qualification is for someone who is seeking to be a Smart Meter (Gas) installer in the Energy and Utilities sector and wishes to prove competence.  There are no mandatory entry requirements but prior attainment of Literacy and numeracy at Level 2 is advantageous.  The Learner must have access to work to complete this qualification.
-What does this qualification Cover	The qualification requires the learner to complete 8 units (all of which are mandatory for meters upto 6m³/hr) and include the assessment of practical skills, knowledge and performance in the work place. The topics covered are:  > Working Safely in the Energy and Utilities sector > Working Practices in the Energy and Utilities sector > Using and Communicating Technical Information in the Energy and Utilities sector > Delivering Customer Service When Working Within the Energy and Utilities sector > Install and Commission Communication Systems for Smart Meters > Applied Practices and Principles for Installing Low Pressure Natural Gas Smart Meters up to U6 only > Prepare, Install and Commission Low Pressure Natural Gas Smart Meter and Regulator up to 6.0m³/hr > Low Pressure Gas Smart Meter Tightness Testing and Direct Purging One optional unit is available for Learners who wish to prove competence for meters above 6.0m³/hr. This is:  > Prepare, Install and Commission medium Pressure Natural Gas Smart Meter and Regulator up to 6.0m3/hr
